Yoogali shared pathway moves ahead

Residents travelling along Mackay Avenue would have noticed significant progress on the eagerly anticipated shared pathway project, which will seamlessly connect Blumer Avenue to Yoogali.

Tree removal works were undertaken on either side of the Main Water Supply Canal and construction has commenced on the first stage of the path, extending from Macedone Road to the Yoogali traffic lights.

This two-year project has been made possible by a \$1.5 million grant through Transport for NSW's Get NSW Active program. The program aims to promote active lifestyles and enhance community connectivity through infrastructure development.

Council has gone to tender for suppliers to provide a design and construct solution for the 42m bridge.

This project represents a collaborative effort between government agencies, community stakeholders, and residents, underscoring a shared commitment to fostering healthy, active lifestyles and creating vibrant public spaces. The project is expected to be completed by mid-2025.

Minister for Agriculture visits Griffith Saleyards

Minister for Agriculture, Regional NSW and Western NSW, Tara Moriarty stopped by the Griffith Livestock Marketing Centre (Griffith Saleyards) to announce an additional \$1.4 million of funding from the NSW Government to support eligible saleyards to prepare for the mandatory roll out of Sheep and Goat electronic identification (eID). The purpose of implementing eID devices at Saleyards is to enhance the traceability and biosecurity within the livestock industry in line with NSW Department of Primary Industries (DPI). This project is fully funded under the NSW Sheep and Goat eID Rebate Scheme.

Minister for Agriculture, Regional NSW and Western NSW, Tara Moriarty, Member for Murray Helen Dalton, Griffith Livestock Marketing Centre Team Leader, Les Warren and Griffith City Council Mayor, Doug Curran were all in attendance.

Griffith Base Hospital facade nearing completion



The colourful facade of the new Clinical Services Building, designed to complement and enhance Griffith's natural surroundings, is the newest addition to the Griffith skyline. The variety of facade colours represent the colours of country and take inspiration from the environment. Construction of the new

hospital is on track and expected to be completed in early 2025. Once the new hospital opens, work will focus on the demolition of redundant buildings, refurbishment of the Ambulatory Care Hub to accommodate community-based services, and extensive landscaping of the health campus.

Memorial Gardens are set to be transformed!

Griffith City Council is thrilled to unveil plans for the rejuvenation of Memorial Gardens, set to commence in early May with an expected completion by the end of October 2024. Councillor Laurie Testoni, Chair of the Memorial Gardens Embellishment Committee, expressed delight about the project, highlighting months of

meticulous planning and collaboration. With a focus on enhancing the park's aesthetics, upgrades to plants and additional pathways are slated, aimed at mitigating foot traffic through garden beds. Council is optimistic that these enhancements will breathe new life into Memorial Gardens.

Major Projects Update

Hanwood Stormwater Pump and Levee

Works on the Hanwood Storm Pump and Levee are progressing well with works commencing on the construction of the pumpstation in Mallee Street which includes electrical works, a concrete slab, the installation of 4 pumps, a covering steel shed and perimeter fencing.

Griffith Mountain Bike Trail

We are in the final stages of completing the entire park facility. The bike trails and skills park area have been completed, while we are currently in the process of constructing the new fencing, driveway, shelter area, concrete works, landscaping and irrigation.

Yenda Kiosk

The upgrades to the Yenda Kiosk are almost complete, with some minor details/materials to be finalised, so we can begin to utilise the brand new facility provided.

MESSAGE FROM CR ZAPPACOSTA

I wish to draw your attention to Griffith's Bagtown Settlement over 100 years ago. The site was 5 kilometres south east of the Griffith township – along the old Willbriggie Road and Research Station Road intersection.

The settlement became known as 'Bagtown' because of canvas cement bags, which were used in the construction of our early channels, and were later used to build huts for the workers.

By 1920, Bagtown became an extremely busy centre with over 100 sites set up. The WI&IC had established their headquarters, along with a police station, school, a cheese factory and many other sites.

When the railways arrived in 1916, many of the Bagtown settlers started to move and re-establish their businesses near the railway station, some 5 kilometres northwest of Bagtown.

Within a few years, Bagtown became deserted because of the relocation to the Griffith community township. Today, there is nothing to indicate that Bagtown actually existed



on that site. There is no signage, no commemorative plaque, nothing at the intersection of Research Station Road and Old Willbriggie Road to show a community existed over 100 years ago.

I have asked Council to investigate the history of Bagtown and the possibility of establishing a commemorative site for Bagtown. If anyone has any information on Bagtown, please contact Council or myself. The feedback received will assist in compiling a record on Bagtown. I appreciate your interest and look forward to your comments on how to record our history.
