- 4. Following completion of the *Application for Reservation* and payment of the appropriate fee Council will issue a Right of Burial.
- 5. Payment for plots in the lawn section may include the cost of a standard plaque. Check with Council when payment is made.
- 6. The holder of a Right of Burial for plots in the general section of the cemeteries will be required to pay any outstanding fees and charges including any expenses involved with the erection of a memorial / plaque.
- 7. The holder of a Right of Burial in a Capella will be required to pay any outstanding fees and charges including any expenses involved with the crypt inscription.
- 8. The Right of Burial can be transferred by the holder to another person subject to the Council being notified in writing and the surrender of the original Right of Burial. A new Right of Burial will then be issued to the transferee. An administration fee is payable.
- 9. The Right of Burial is a secured title for the use of a particular plot/vault/crypt at the Griffith or Yenda Cemetery and has legal standing in recognising the entitlement of interment, regardless of any changes of ownership of the Capella.
- 10. The Right of Burial Form must be surrended to the Funeral Director when making the Funeral arrangements.
- 11. Where the Capella is privately owned, the Application for Reservation or interment in a crypt must be authorised by either the owner of the Capella, if deceased, then the executor of the estate, or the person(s) nominated in the will instrument instruction defining crypt access or entitlement.
