- Griffith Regional Art Gallery opening hours are Wednesday to Friday 10am to 5pm. Saturday and Sunday 11am to 2pm.
- GRAG is entitled to 30% commission from all sales.
- Products will be on consignment for three months. After this period, applicants can re-apply.
- Consignment will be settled at the end of each calendar month.
- Applicants will be assessed by a panel of GRAG staff with no negotiation on final decision.
- GRAG reserves the right to select and limit particular products. It is up to the discretion of GRAG panel.
- All packaging must be supplied by applicant.
- Griffith Regional Art Gallery reserves the right to take digital images of products for use of promotional purposes.
- The Artist reserves the copyright and all reproduction rights to these works.
- The retail amount, less Gallery commission, will be remitted to the Artist within thirty (30) days after the month of sale.
- The Artist needs to provide ABN number or a Statement by Supplier form from the ATO website before being paid.
- The Gallery will assume full responsibility for any consigned work lost, stolen or damaged while in its possession.

  Insurance of works while in transit will be the responsibility of the entrant. Consigned works may not be removed from the Gallery premises for purposes of rental, instalment sales or approval with a potential purchaser without the Artist's permission. The specified retail prices may not be changed without the Artist's permission.
- The consigned works will be held in trust for the Artist's benefit and will not be subject to claim by a creditor of the Gallery. Either party may terminate this agreement by giving thirty (30) days written notice, with all accounts settled.
- All applicants will be contacted about their application by email within a fortnight of applying.
- Works that have been accepted for Griffith Regional Art Gallery Shop must include a pre-paid & registered return
  express bag/packaging. Products that are not sold will need to be returned at the artists expense after the 3 month period. If local, owner can pick up products. If not collected or arranged postage, Griffith Regional Art Gallery will dispose
