Message from Councillor Glen Andreazza

As we slowly come out of what we hope is the worst of COVID-19, after spending the last few months in lockdown, I would like to remind the community to remain vigilant and keep practising social distancing and hand hygiene to keep each other safe and maintain the excellent health of our community.

This has been possibly the only time that our distance and isolation from major cities has been a huge positive for all our residents - it has kept our infection rate down and we have not had a case since the initial outbreak in March.

In keeping with social distancing rules, Council have been streaming meetings via Facebook and a positive that has come from this is that more members of the community are tuning in and keeping up with the fortnightly meetings.

It is great to see so many residents being able to see what it is we do at Council Meetings, and to be more aware of the decisions we are making and the reasons behind them.

While trying to get back to business as usual I will endeavour to keep my report "COVID free" and keep everyone updated on the notable items happening in and around our city.

The 'fish kill' at Lake Wyangan has possibly been the most distressing event to hit Griffith other than COVID-19.

Council has undertaken testing of the water and fish and we are expecting some results by the end of this week.

We hope these tests shed some light on what has happened - given the negative reporting on this distressing issue I want to assure the community that Council is doing

everything possible to resolve the issues with the Lake. This is a lengthy and complicated process and unfortunately, there are no quick fixes.

An exciting joint project to build Affordable Housing in Griffith has just been approved as a three-way partnership. This long overdue major venture is with thanks to Sussan Ley and the Federal Government who are contributing \$6Million, Griffith City Council contributing \$3Million including land, water and sewerage works, and Argyle Housing contributing a further \$3Million.

We hope this project will help to ease the housing crisis in Griffith and create job opportunities in the foreseeable future.

I look forward to further details emerging and Council will keep you updated.

Everyone would have seen the work progressing at the Yoogali Intersection, which is a welcome and long overdue upgrade that will make this notorious piece of road safer for all of us.

We thank you for your patience while works are underway, but know the final results will be well worth the inconvenience as we strive to make our roads safer and more efficient.

The Yambil Street stage 2 upgrade is progressing well and on track due to be completed in the coming months. I hope the community is as happy as I am with the results, which include much better drainage, lighting and beautification of this very busy street.

Another exciting development which has just been approved is the construction of a new service station, vehicle repair station and

specialised retail premises on the intersection of Stafford Road and the Kidman Way opposite Bunnings.

This large scale investment will bring a huge economic injection into Griffith, utilising local trades and business and creating jobs. Given the distressing, frightening times the community has suffered over the last 3 months it is comforting to see the town continuing to grow and thrive despite COVID-19. This just proves the unique, resilient town we are all lucky enough to live in.

If you intend on travelling during the upcoming school holidays, please stay safe.

Until my next catch up, stay well, wash your hands and continue to practice social distancing as we all look after each other.

Griffith City Council COVID-19 relief program opening soon



Community groups, not-for-profit organisations and sporting bodies in the Griffith Local Government Area affected by the COVID-19 pandemic have been thrown a lifeline thanks to Griffith City Council's new Relief Grant Program.

Council's COVID-19 Relief Grant for the 2020/2021 financial year will open on 1 July 2020.

A maximum of \$5,000 is available for each eligible application, with the funds to be used for projects aimed at assisting organisations affected by the COVID-19 lockdown.

At the Extraordinary Meeting of Council on 5 May 2020 Councillor Doug Curran put forward a Notice of Motion suggesting a number of strategies to assist residents and

businesses severely affected by COVID-19, including the new Relief Grant.

"Council recognises that organisations and community groups delivering essential services to the local community have been impacted during the pandemic," said Councillor Curran.

"Under this new Grant we have made a total of \$100,000 available. This is just one of the ways we are supporting our community during these exceptional times."

The COVID-19 Relief Grant will open on 1 July 2020 and close when available funds are exhausted. Each of the applications received will be assessed monthly and approved by Council.

To be eligible, applicants must provide details of how the COVID-19

lockdown has impacted their organisation and how the funds will address that impact.

Mayor John Dal Broi is encouraging affected groups to submit an application.

"I'd urge any local organisations who are eligible to look at making a submission as soon as it opens," Councillor Dal Broi said.

"I'm happy that we are able to lend support to the Griffith community in this way."

Ready, set, borrow! Griffith City Library welcomes back members

Griffith City Library welcomed back members and visitors last month, as restrictions eased across the State.

Library Manager, Karen Tagliapietra said, that while things were operating a little differently, staff are working hard to deliver services.

"During the COVID-19 lock down period, we continued to offer as many services as possible online - including our popular Story Time sessions," said Mrs Tagliapietra.

"A very popular service is our free e-resources which are available 24/7 via our website.

"You can access items such as eBooks, Audiobooks, online magazines, the Encyclopedia Britannica and other research tools."

Library staff are continuing to host

a number of online programs and activities including virtual Story Time and Rhyme Time, keeping your children entertained from home.

"A service we have introduced is the Click Collect Borrow - you can reserve items online and collect from the Library to limit your time in the facility," said Mrs Tagliapietra.

"Of course, you can also pop into the Library to browse and borrow your own items during our normal opening hours."

A home delivery option is available for eligible Home Library members - contact staff on 6962 8300 for more details.

"Our free wifi is available during opening hours, however the public computers are

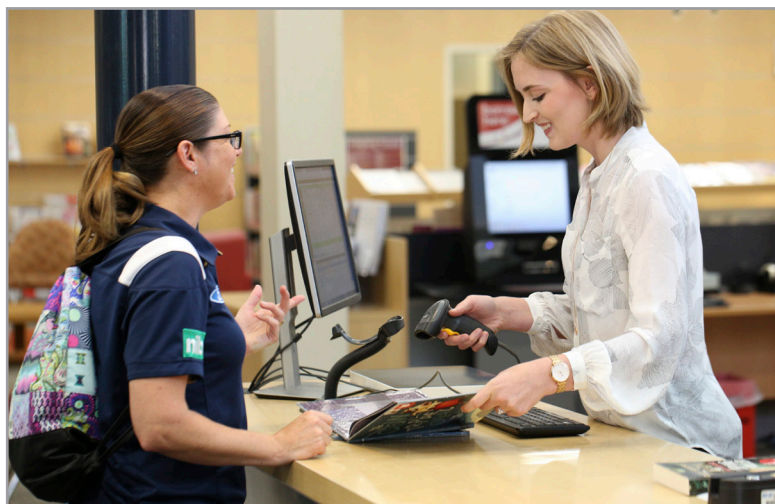
restricted to one hour per day and have been limited to allow for appropriate social distancing measures," she said.

"You will need an active Library membership to log in - membership is free, as is the use of the computers."

Additional measures are in place to ensure the safety and wellbeing of staff and patrons, including the quarantining of returned items for three (3) days before being returned to the shelves for borrowing.

"We are excited to be welcoming back our members and visitors, and appreciate your understanding with the limited services being offered," Mrs Tagliapietra said.

GRALC set to welcome back swim school students

With the easing of COVID-19 restrictions across the State, Griffith Regional Aquatic Leisure Centre is excited to be able to recommence swimming lessons with Splash Swim School.

Leisure Services Manager, Mr Alan Anderson said students will be able to resume lessons from Monday 20 July.

"Preparations are under way and our instructors are very excited to be able to get back in the pool to provide swimming lessons," said Mr Anderson.

"While restrictions have eased, we will be following the guidelines as set out by the NSW Department of Health and Swimming Australia.

Staff will be implementing procedures to ensure the safety and wellbeing of our customers,"

added Mr Anderson.

Enrolments for Term 3 will commence Monday 29 June. Students who were on direct debits will be automatically enrolled at their previous level and day. Emails have been sent to enrolled families outlining the details of their lessons.

"If your child is a current student and you wish to make changes to their enrolment, please contact us on 6962 8228," said Mr Anderson.

"Unfortunately due to the social distancing rules, we are unable to offer Baby Play or Toddler Time lessons and current enrolments for these lessons will remain on hold."

It is important to remember when attending lessons to follow the restrictions and procedures in place:

- *If you or your child are unwell and have flu like symptoms please do not attend the centre. Contact us and we will arrange a make up lesson for your child.

- *Hand sanitiser is available at front reception and should be used upon entry. Instructors will also have this available poolside.

- *Due to social distancing rules and the limited available seating within the Centre, we ask that only one parent attend lessons with their child. This parent will need to sign in at front reception for contact tracing purposes as per the NSW Government rules.

- *Please limit the amount of time you spend at the Centre. We ask that you come ready to swim and minimise the amount of time using changerooms.

- *We will be implementing staggered start and finish times for our staff in order to limit the amount of people at the Centre at one time. This means that there will be a change to the current timetable.

- *Equipment will be cleaned and sanitised after each class

"We have a COVID safe return to swimming lessons plan and have carried out risk assessments to ensure the safety and wellbeing of our patrons and staff," Mr Anderson said.

"We appreciate your cooperation and look forward to welcoming our swim school students back to the water next term."

Griffith Can Assist awarded City2Lake event for 2021/22



At the Ordinary Meeting of Council held Tuesday 23 June 2020, Council considered the Expressions of Interest for the 2021/22 City2Lake, awarding local organisation Griffith Can Assist the rights to host the event.

Griffith Can Assist have been involved with the City2Lake since its inception in 2013, taking over hosting the event for two years in 2019 and 2020.

The charity assists local cancer patients with costs associated with their treatment including medications, travel and accommodation.

President, Griffith Can Assist Olga

Forner said she is extremely happy and relieved to have been awarded the event for the next two years.

"The service we provide to the local community goes a long way to easing the financial issues faced by cancer patients across the Griffith area," said Mrs Forner.

"Securing this event is a real life line to our Griffith branch, given we have been unable to host any fundraising events due to the COVID-19 pandemic.

"Cancer stops for no one and without the fundraising associated with the City2Lake, the future of Griffith Can Assist was in doubt. Now we can proceed with some

assurance that we can continue to provide financial assistance to some of the most vulnerable members of our community."

The 2020 event hosted by Griffith Can Assist raised over \$66,000 with more than 1,000 people running, walking or cycling to Lake Wyangan.

"We hope that we can make 2021 an event bigger event, with more registrations to help support local cancer patients," added Mrs Forner.

Griffith Mayor Councillor John Dal Broi said he was pleased Council could support and assist Griffith Can Assist with the event over the

next two years.

"The work undertaken by this organisation is extremely important to our community, easing the burden felt by cancer patients and their families," said Councillor Dal Broi.

"Council recognises the efforts of the Griffith branch over the last two years in particular in putting together this event, and I look forward to seeing what the committee can deliver next year."

New service station approved for Griffith

A new petrol station is set to be built in Griffith after Council approved a development application on Tuesday night.

The proposed development, located on the Corner of Stafford Road and Kidman Way, includes the United Petroleum service station and associated advertising signage, three specialised bulky goods stores, a mechanics workshop, parking spaces and landscaping.

The approval was granted at Council's Ordinary Meeting on Tuesday 23 June 2020, which was held remotely via Zoom and livestreamed to Facebook.

Griffith Mayor, Councillor John Dal Broi said this decision demonstrates Council's commitment to encouraging and supporting the establishment of

new and diversified industries and businesses.

"I am happy that Councillors have come to agreement so that this development can move ahead," Councillor Dal Broi said.

"It is good news for our City that we have businesses such as this interested in helping us grow.

"I acknowledge that we had some concerns from residents but they have all been addressed and at the end of day due process has been followed. I thank the developers for their patience and staff for their efforts."

It is estimated the new development will create around 80 new employment opportunities for Griffith and will operate within standard business hours with the potential for some weekend trading.
