

COUNCIL CATCH-UP

Full steam ahead for Yambil Street Stage 3 and 4



September saw the conclusion of the Stage 2 works on Yambil Street, paving the way for Council to commence Stage 3 and 4 of the redevelopment project.

Griffith Mayor, Councillor John Dal Broi thanked businesses, shoppers and road users for their patience during Stage 2, which saw the sections between Kooyoo Street and Ulong Street upgraded.

"I would also like to congratulate our staff and contractors for their work, and I am pleased to see how the streetscape is coming together," said Councillor Dal Broi.

"These upgrades are part of the overall CBD strategy and we aim to provide a quality and functional environment throughout the CBD – I think you can agree we are achieving this outcome with the works completed throughout these initial stages of Yambil Street.

"Now Council is moving forward with Stages 3

and 4, which are set to commence at the end of this year," he added.

Council staff are currently advising businesses located within the Stage 3 and 4 sections from Ulong Street through to Kookora Street to provide information and answer any questions.

"I would encourage you to stop and have a chat with the staff, clear up any concerns and find out what these next stages mean for your business," said Councillor Dal Broi.

"Works being undertaken include the replacement and redevelopment of infrastructure and road paving, landscaping including new street trees, additional seating and bins, and new footpaths."

Director Utilities, Mr Graham Gordon said Council will be conducting an information session for business owners, landlords and any interested community members at 6pm Thursday 29 October, at the Griffith Exies.

"This is a great way to gain a complete understanding of what the upgrades will mean for your business and other users of Yambil Street and staff will be able to answer your questions," said Mr Gordon.

"RSVPs are essential due to COVID-19 restrictions, so please ensure you have sent through your intention to attend before Monday 26 October."

Council urges residents to be weed wise



Griffith City Council is encouraging residents to be on the lookout for a dangerous evasive weed known as Parthenium (Parthenium hysterophorus).

Council's Biosecurity Weeds Officer, Peter McGrath said, Council is working with NSW DPI to raise awareness of the problem weed.

"New incursions have recently occurred further north in NSW coming from Queensland, where the weed is endemic. It is transported into the region via various vehicles and means, such as machinery, cars, trucks and stock feed. We urge the public to be on the lookout for Parthenium plants along roadsides, rest areas and paddocks," he said.

The weed is identified as a significant biosecurity risk in NSW and is prohibited under the NSW Biosecurity Act 2015.

Parthenium weed spreads rapidly, is dangerous to grazing animals and reduces crop and land values. Contact with the plant or pollen can cause serious allergic reactions in people.

Parthenium weed grows quickly. It outcompetes other plants by fighting for nutrients and moisture

and by releasing chemicals into the soil that inhibit growth.

Parthenium weed:

- causes human health problems, such as respiratory problems and severe dermatitis
- is unpalatable to stock
- outcompetes degraded or drought affected pastures
- reduces carrying capacity
- causes livestock health problems
- competes with crop seedlings including sunflowers and sorghum
- reduces crop yields
- contaminates grain
- is a host for crop viruses.

If locals suspect they have seen Parthenium weed they are encouraged to note the location, do not attempt to treat or dispose of this weed yourself and call the NSW Biosecurity Helpline, 1800 680 244, NSW DPI, Local Land Services or contact Council on 1300 176 077 with the details for identification and assistance.

Council Awards Round 3 of COVID Relief Grants

Griffith City Council has awarded funds to three community groups impacted by the COVID-19 lockdown after the third round of applications were assessed.

As part of the 2020/21 Budget, Council established the COVID-19 Community Grants Relief Fund of \$100,000.

Under the program, a grant of up to \$5,000 is available to community groups, not-for-profit organisations and sporting bodies for eligible projects aimed at assisting those organisations affected by the COVID -19 lockdown.

The Communities Committee assessed six applications in September totaling \$26,600, determining the eligibility for the COVID relief grant, and awarding just over \$9,000 to three organisations.

At the Ordinary Meeting on 13 October 2020 Council endorsed the following COVID 19 Community Grants Relief Fund applications;

- Hanwood Public School P&C Association - \$1,600
- Griffith Public School P&C Association - \$5,000
- The Australian Man Cave Support Group (Griffith Chapter) - \$2,500

Councillor Doug Curran is encouraging eligible groups to consider applying.

"Council is pleased to be able to support the community through the COVID-19 Relief Grant and with

so many applications coming in, it's obvious that there is a real need in our community for this level of support," Cr Curran said.

"So far we have distributed close to \$70,000 to eligible groups, leaving around \$30,000 available. I would encourage your community group, not for profit organisation or sporting group to visit the Council website to see if you are eligible and put in an application for the next round."

The Communities Committee have established a set of guidelines to assist groups submitting an application.

Guidelines used to assist assessments are as follows:

- Project or resources requested must be directly related to COVID-19
- Ongoing administrative or operational costs not eligible
- Capital purchases must be directly related to or demonstrable against losses incurred due to COVID-19
- Evidence and supporting documents demonstrating impact of COVID-19 should be supplied
- Projects and organisations must be in the Griffith Local Government Area

The COVID-19 Community Grants Relief Fund is ongoing until funds are exhausted.

Message from the Mayor, Councillor John Dal Broi



At the last Ordinary Meeting of Council held Tuesday 13 October 2020, Councillors resolved to extend the General Manager's contract for a period of three years.

Since 2011, Mr Stonestreet has worked closely with Councillors to drive our economy by obtaining millions of dollars in funding for the City. This has realised many major projects to improve the City, many of which have been unfunded for years.

It is hard to drive anywhere around Griffith and not see a Council project underway.

Council has been able to deliver the \$25M Sports Precinct (50m pool and extension of Westend Stadium and Jubilee Oval), creation of the Country University Centre, upgrades to City Park and Community Gardens, Memorial Garden, Entiknap Park, Henderson Oval, Southern Industrial Bypass, Boorga Road seal, CBD upgrades including Yambil Street, Griffith Airport redevelopment, Griffith Youth and Community Centre, affordable housing developments (Pioneer Estate and Wakaden Street units), the Hanwood Cycleway and the Yenda EMR.

As well as creating work for our staff these projects have generated work for local businesses and trades injecting millions of dollars into our economy.

Pleasingly our Council is in a strong financial position and is one of only two Councils able to offer rate rebates for our community. Overall we are travelling in the right direction toward a strong and prosperous future for our community.

The construction of the 50m pool is on track for a Summer 2021 opening, while work is continuing at Westend Oval and Jubilee Oval. This is exciting progress for our region, forming part of the Regional Sports Precinct which will allow larger sporting events to be held. In turn this will inject funds into our community through meals, accommodation and other activities.

The Griffith Southern Industrial Link is progressing, but I would like to make mention of vandalism which has taken place over recent weeks. It is disappointing to see

Council property damaged at these worksites which cause not only unnecessary delays, but expensive repair bills. If you witness any acts of vandalism be it on Council worksites or other community and Council facilities, please call the local Police and report it. Council offers a reward for any information leading to a conviction.

This week saw the commencement of the HSC for students across NSW. I would like to take this opportunity to wish them all the best with their exams, but also remind students that this has been an unprecedented year.

While the HSC is an important end to your higher school studies, remember there are other avenues you can take - 2020 has been extremely difficult for everyone, I cannot imagine how hard it would be to attempt to complete your HSC during this pandemic situation.

I have no doubt this generation of students will be resilient. No matter what the results, never give up on your dreams for the future.

COVID has been trying for us all and if you are struggling or need someone to talk to, please reach out. There are a number of services available to assist - visit health.nsw.gov.au for more information.

Lastly, I would like to mention two local heroes who have been recognised for their outstanding contributions. Yenda residents, Kay Pellizzer and Barbara Jefferies were noted on the 2020 Hidden Treasures Honour Roll, which was launched last week by The Honourable Adam Marshall MP, Minister for Agriculture and Western New South Wales. This year 104 rural women were recognised for the contribution they have made through volunteering and it is wonderful to see two local women being honoured in this way.

Notice of Temporary Road Closures

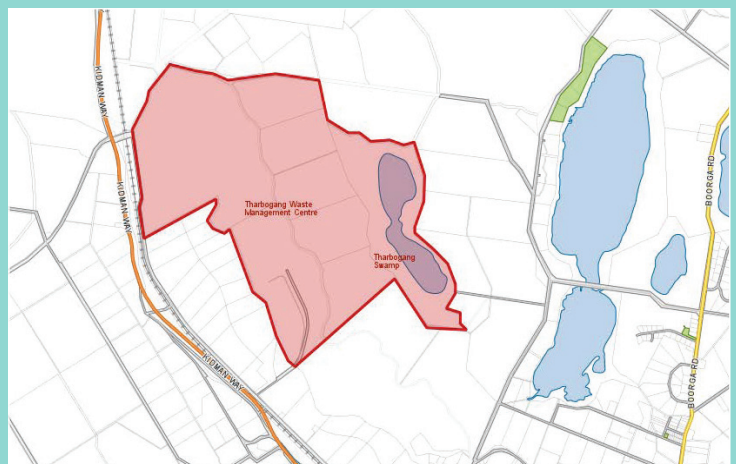
