Campbell's Swamp: explore Griffith's best kept secret



The best kept secret in the Griffith City Council area, Campbell's Swamp is a spectacular natural wetlands the local community and visitors can enjoy.

The hidden gem is located on the corner of Boorga and Jones Roads, just a short drive, walk or ride north of Griffith and on the way to Lake Wyangan.

Campbell's Swamp has an area of approximately 85 Hectares, including the wetlands and adjacent area.

The bird lover's paradise is a black box-lignum swamp containing extensive open areas punctuated by stands of reeds and cumbungi.

Water levels in the swamp are managed through environmental allocations from the Commonwealth Environmental Water Office and the NSW Department of the Environment.

Griffith Mayor, Councillor John Dal Broi

said, "Campbell's Swamp is recognised as a significant habitat for a range of water birds, including a number of threatened native species, including the Australasian Bittern, and water birds listed on International treaties."

Australasian bitterns, little bitterns black-winged stilts, glossy ibis, freckled ducks, plumed whistling ducks and magpie geese have all been spotted at the swamp in the past.

"Birdwatchers from around the world are attracted to Campbell's Swamp due to the diverse range of birds which can be found there at different times of the year," said Councillor Dal.

"The shallow water level makes it ideal for foraging while the reeds and rushes provide shelter and harbour insects and frogs which provide another source of food for the waterbirds.

"It really is one of the best kept secrets in our Council area especially if you enjoy waterbirds.

"I'd urge anyone thinking about visiting to be mindful of the natural environment and take care to help protect the wildlife because the Swamp is an important breeding habitat," he added.

Thanks to environmental water, the site provides ideal habitat for a long list of waterbirds that are feeding on the mudflats and/or breeding in the rushes.

Access to Campbell's Swamp can be gained from a parking area off Boorga Road. A boardwalk leads to a bird hide located in the swamp. Caution is advised when using the boardwalk.

Visitor facilities including the boardwalk, and birdhide have been constructed and maintained by the Murrumbidgee Field Naturalists.

"I am passionate about our community and look forward to working with the Mayor and the rest of Council to achieve the goals set out in our last year of

the Council Term," said Councillor Croce.

"I thought it was time I threw my hat in the ring to have a go. I'm looking forward to continuing to work with my fellow Councillors to get things done. We have a lot ahead of us and despite the naysayers, we are achieving a lot. I consider it a great honour to represent this community and as Deputy Mayor I'll do my best to support the Mayor in any way I can," he said.

Mayor John Dal Broi welcomed Councillor Croce's election as Deputy Mayor, saying the two have always worked well together.

"I congratulate Councillor Croce and look forward to working with him," he said. "I'd also like to thank Councillor Curran who has performed very well in the role over the past two years."

Griffith celebrates Wiradjuri culture



The Griffith Regional Art Gallery has taken over the old Telstra shop at Griffin Plaza, which has been transformed into a gallery showcasing Wiradjuri art and crafts, and an information hub for the Yarruwala Wiradjuri Cultural Festival.

The pop-up gallery features works by senior Wiradjuri artists, Veronica Collins, Cory McKenzie, Will Carter and many others, as well as demonstrations and art activities.

Griffith City Council is working with the local Wiradjuri community, Western Riverina Arts and Burrundi Theatre to present a program of exhibitions, performances, workshops and immersive cultural events which celebrate the strength, resilience and diversity of Wiradjuri culture.

At the heart of the festival is the World Premiere of *Sunshine Super Girl*, by writer-director Andrea James, celebrating the life and achievements Evonne Goolagong-Cawley, presented by Griffith Regional Theatre at Westend Stadium from 7-10 October.

Griffith Regional Arts and Museum Manager, Raina Savage said, as well as this incredible performance the public can meet Andrea James in a free Q and A session, or pick up some tips in a story and script writing workshop. "There will also be spectacular Welcome to Country curated by Director of Burrundi Theatre, Kerry Johnson livestreamed from the stadium grounds," said Ms Savage.

"The Theatre is presenting free screenings of *In My Blood it Runs* and films by Wiradjuri film maker Mitchell Stanley - *Servant or Slave* - the powerful and confronting story of elderly Wiradjuri women who were forcibly removed from their families and made to work as unpaid domestic servants and *Closed Doors* featuring Rhimi

Johnson Page."

Communities across the region are showcasing Wiradjuri stories and culture. The festival program features Aboriginal cultural experiences including cultural tours by Wiradjuri Elders William Ingram (Leeton) and Michael Lyons (Narrandera), and art workshops by leading Wiradjuri artists – Dr Treahna Hamm, Cory McKenzie and Aunty Gail Manderson and Melanie Evans.

One of the main events of the festival is *One Night on Warangesda* presented by Burrundi Theatre.

Burrundi Theatre Director Kerry Johnson said *Warangesda* is the soulful element of the Festival, never before have we attempted to dig so deep.

"We will awaken country, and listen to its rumblings of stories past, a passage of spirit and survival," she said.

Chairperson of the Cultural Facilities Committee, Councillor Mike Neville said he is pleased Griffith City Council can be part of this culturally significant festival.

"The Yarruwala Wiradjuri Cultural Festival will be a fantastic event and I am extremely pleased that our community have the opportunity experience it," said Councillor Neville.
