

COUNCIL CATCH-UP



Trees removed to make way for sporting infrastructure

Griffith City Council would like to advise the removal of a number of trees at both the Griffith Aquatic Leisure Centre and Jubilee Oval sites which were required to facilitate the building of new grant funded sporting infrastructure.

A total of 14 trees on the GRALC site were removed in order to accommodate the new 50M pool and associated infrastructure. These trees were predominantly on the back boundary of the site.

A total of 22 trees have been removed on the western boundary at Jubilee Oval in order to build a new large scale Amenities Building, with a new rugby field adjacent to

the front of this building.

Griffith City Council's General Manager, Mr Brett Stonestreet said while this was an unfortunate loss, it is essential for the sporting projects.

"In order to move forward with these exciting projects, land needed to be cleared at these sites," said Mr Stonestreet. "In the upcoming budget Council will consider the design and costing for a new car parking area along Cutler Avenue, and this will look to incorporate new tree plantings. If adopted, these plantings will assist in offsetting the loss of some or all of the trees."

Yambil Street Parking Restrictions



Griffith City Council would like to advise that parking restrictions in Yambil Street have been reinstated until construction of Stage 2 is completed.

All Yambil Street users should be aware that there is an enforced two hour parking restriction in the designated area.

There will be unrestricted parking from the Council car park (Next to GB's Sports) to

Kookora Street during this time.

Council recently conducted a survey to gauge what the majority of businesses in Yambil Street would like to see regarding parking restrictions while construction continues on Stage 2. The majority of businesses from Jondaryan Avenue to the Council car park next to GB's Sport voted to have the two hour parking restrictions reinstated.

Council to cover the cost of Mlak keys

The cost of obtaining a Mlak key has been waived for eligible residents following a Notice of Motion put forward to Council.

The Mlak key gives people with a disability 24 hour/7 days per week access to public facilities across Australia. The system, developed by the Master Locksmiths, ensures people with a disability always have access to clean and safe facilities if and when other public facilities are not available or closed. The \$20

fee for the key will now be covered by Council after an application has been made at the Griffith City Council's Customer Service Centre at 1 Benerembah St Griffith.

In addition to toilets under the Mlak system, Council also operates a number of ambulant toilets at the Griffith City Library, the Griffith Visitors Centre, the Griffith Regional and Aquatic Centre and Memorial Park which are available when facilities are open.
