## Council's 'Build More Dams Committee' calls for action

fish at Menindee has prompted renewed calls by the Griffith City Council Build More Dams Action Group to have a proposal to divert water from the Clarence River to the Murray Darling Basin taken seriously.

Build More Dams Action Group Chair Councillor Dino Zappacosta said recent events at Menindee and beyond had only confirmed the need for action.

"It's a crisis and things will only get worse if something isn't done. We can't let what is happening continue without taking another look at this scheme. We've tried almost everything we can think of to get Government to make been able to get anywhere," Cr Zappacosta said.

"There has been public outcry over the fish at Menindee due to the lack of water in the Darling River. I truly believe the answer is to look at our scheme so we can get more water down the Darling to where it's needed.

"We've been doing this for a while. Primarily to encourage Government to look at the possibility of building dams to capture more water to be used particularly in inland Western NSW Region."

Over the years the Group has approached countless politicians and both federal and state government to look at the possibility of a feasibility study on the Clarence River Diversion Scheme, which was prepared by engineer David Coffey.

"He came up with the scheme in 1984 which showed, in his opinion, that water could be dammed in the Clarence/ Northern NSW region and piped through the Great Dividing Range through a tunnel feeding into the Darling River," Cr Zappacosta said. > "In the last five years our Working Party has lobbied other local government west of The Great Dividing Range and got support from most of them, from the Murray Darling Association, which encompasses local government all the way from the Coorong District in South Australia all the way up to Queensland.

Cr Zappacosta said there had been plenty of support for the scheme in the past.

"Three years ago the NSW Shires Association supported the concept of a feasibility study into the diversion of the Clarence River. Then we went off to the

the Australian Local Government Association and at their national conference two years ago in Canberra they wholeheartedly supported the concept of calling on the Federal Government to get behind it," he said.

"It gave me a lot of heart to have so much support from Federal, State and Local Government.

"We've tried almost everything, we've looked at all possible avenues to make this happen but we're not getting anywhere. With what's happening at Menindee we need to look at a scheme that is more plausible and will assist this region. We just need more water down the Darling."
