Keep safe during grape harvest

With the 2021 grape and wine vintage now underway, a reminder has been issued to all road users to help keep local roads safe to ensure this year's crop gets from the farm to receival points as intended rather than being spilled across the region's roads.

Griffith City Council's Road Safety and Traffic Officer Greg Balind said complying with relevant legislation and allowing heavy vehicles plenty of room while sharing the road not only ensures safety on the roads but minimises the potential for fruit and juice spills across the road network.

Enforcement will be undertaken across the region throughout the harvest to ensure vehicles comply with restrictions and that loads are secured according to the Chain of Responsibility laws.

When a grape spill occurs and vehicles are identified, heavy fines

can be applied under the Protection of the Environment Operations Act and any additional costs associated with clean-ups will also be passed on to operators.

There is a responsibility on other road users to give heavy vehicles the space needed on the road to make their respective journeys as safe as possible.

Residents can report a grape spill by calling Council on 1300 176 077 during business hours or 6969 4823 after hours (J&J Security.)

Carp to be removed from the Lake



Council continues to take an evidence based approach to the restoration of Lake Wyangan.

This week contracted removal of European Carp will be undertaken in Lake Wyangan (North). The work is being carried out under a permit from NSW Fisheries.

European Carp are bottom feeders and continually disturb the fine sediment at the bottom of the Lake. The primary purpose of the exercise is to remove as many Carp as possible from the Lake. All fish caught, whether they are pests or native species, will be recorded and reported. All native species will be returned to the Lake.

Council is also investigating installing screens on the escapes of the main canal to prevent larger carp coming into the Lake.

The Carp removal work will be carried out up until Wednesday, 17 February 2021.

The Lake Wyangan Catchment Management Committee met for the first time this year last week, with a host of agenda items discussed. There are several issues/challenges which the Committee is working through, including:

- Reducing the prevalence of blue/green algae blooms
- The quantity and condition of the existing sediment in the Lake built up over several decades
- Minimising further sediment discharge into the Lake
- Reducing the salinity content in the Lake
- Additional fresh water inflow required as a consequence of reduced inflow from farms
- Improving water circulation in the Lake
- Respecting the Aboriginal cultural significance of the Lake Wyangan foreshores.

General Manager Brett Stonestreet said, "There is no "silver bullet" to address these issues but the Committee is working hard with investigating options that it considers will provide best value for money for the community. Once further research is undertaken with these options, there will be ample opportunity for the Community to provide input."

The removal of Carp is just one of a range of targeted exercises being undertaken as part of the wider remediation process.

Fisheries have released 5000 Murray Cod and 5000 yellow belly fingerlings into Lake Wyangan over recent months.

Council remains committed to ensuring any money spent on the Lake offers the best and most cost effective results for the whole community. Residents are reminded that Lake Wyangan was not intended to be a Lake, but is a drainage basin for both irrigation and urban systems, as a result it contains more than 50 years of build-up issues including sediment nutrients.

Council is working hard to find a solution, investing heavily in the best Lake restoration science in the country including scientists from Water Research Australia, the University of NSW and Professor David Hamilton from Griffith University who is recognised internationally as one of the world's leading lake restoration scientists.

A Red Alert level warning is currently in place at the Lake.

Yambil Street Stage 3 temporarily delayed after water seepage detected

Work on the Yambil Street upgrade Stage 3 has been delayed due to the discovery of water seepage in the underlying soil.

Works on Stage 3, from Ulong Street to Daines Street, commenced early December 2020 with the removal of existing bitumen and kerb and gutter, the excavation of soil under the bitumen seal, in accordance with the initial geotechnical investigation report, installation of a new water main and additional sewer works. Following the removal of the subgrade soil in the travel lane, water seepage was detected and additional geotechnical investigations were undertaken.

The results of the additional soil tests confirmed water seepage and it was recommended that excavation and removal of additional soil below the road pavement be undertaken and replaced with more suitable material in

addition to subsoil drainage being installed along both sides of the Stage 3 Yambil Street project.

At the Ordinary Meeting on Tuesday night, Council approved the variation to the contract for Yambil Street Upgrade Stages 3 and 4 as submitted by B & C Plumbing for the removal of unsuitable material and replacement with "select fill" and installation of sub-soil drainage in line with geotechnical recommendations.

Griffith Mayor, Councillor John Dal Broi, said the discovery meant unavoidable delays.

"It is extremely unfortunate and we do feel for the businesses affected, but this is something that is beyond our control," Cr Dal Broi said.

"Yambil Street has certainly presented many unexpected challenges, this is just another that

we have to deal with.

"I want to thank our community and in particular Yambil Street businesses for their ongoing support and patience. Please know that we are working to ensure that the end result is worthwhile."
