Griffith comes alight with Glow2680

Griffith residents were left in awe as the much anticipated launch of Glow2680 was held last Friday night.

Griffith Mayor, Councillor John Dal Broi and Chair of the Christmas Working Group, Councillor Dino Zappacosta were on hand to 'hit the button' and turn on the lights of Banna Avenue and Memorial Park.

Councillor Dal Broi said he was amazed at the number of people who braved the heat to come out and celebrate the event.

"It was an honour to be able to turn on the lights and see the reaction from the community when everything was lit up," said Councillor Dal Broi.

"We were fortunate to have funding from the Local Roads and Community Infrastructure Program which made this possible, but this has been a long term vision of Councillors and Council staff.

"The funding was stretched as far as possible,

with an additional 20 Plane trees covered in fairy lights, and the addition of the bauble, extra stars and a new Christmas Tree for Griffith and Yenda - this truly is a Christmas to remember," he added.

Stores along Banna Avenue stayed open for late night shopping as part of Glow2680, reminding residents to spend their dollars locally this Christmas.

Director Economic and Organisational Development, Ms Shireen Donaldson said Glow2680 was a great way to promote our local shops, cafes and restaurants.

"The Council team developed the Glow2680 website to assist retailers and food outlets in promoting their businesses throughout December," said Ms Donaldson.

"We understand this has been a tough year for many and wanted to work with local businesses to encourage our residents to shop local this Christmas - every dollar spent

locally assists not only the business, but the wider community.


"It was great to see so many taking advantage of the late night shopping, particularly the boutique stores which we are so fortunate to have here," she said.

A busy time for Council with over \$70M in projects underway

Griffith is booming, according to Griffith Mayor John Dal Broi who said Council is currently progressing with more than \$70M in infrastructure projects across the Local Government Area.

"You don't have to look far to see a Council project – from the Southern Industrial Link Road, footpath construction in the villages, the Regional Sports Precinct, right through to affordable housing and the community centre – this Council is working hard to deliver essential services to our community," said Councillor Dal Broi.

"It has been an extremely busy year for Council staff and it certainly doesn't look to be slowing down any time soon with 2021 filled with ongoing and new projects.

"It is certainly a great time to live, work and play in Griffith!" he added.

Several projects are underway including:

Griffith Regional Aquatic Leisure Centre - 50m Pool

The formwork and reo to Bleachers on the north & south concourses will be done this week, with the gas, water and pump out line from the plant area to the amenities installed. Electrical works are continuing, as it the tiling to the northern & southern pool hob and amenities. Clearing works will be undertaken this week in preparation for excavation to new levels. The project is on track for a late January 2021 opening.

Westend Stadium

The design phase for the Stadium is nearing completion and the DA has been lodged. Council has completed the Expression of Interest process to identify a suitable pool of construction contractors who were invited to tender, with tenders opening earlier this month. Tenderers will be presented to Council in December/January 2021 and a contractor appointed, with construction expected to commence early 2021.

Jubilee Oval

The Jubilee Amenities block is progressing well, with the concrete tilt panels constructed, the internal slabs have been poured, bracing is now installed and trusses

are being installed this week. The roofers have been booked in for this week, and the concrete blocks for internal work should be delivered this week also. Everything is on track for a mid-February 2021 completion.

Community Centre

The construction of the new Community Centre is fully funded with the NSW Government funding \$3.65M and Griffith City Council and Country Universities Centre - Western Riverina each contributing \$440K, following years of lobbying by Griffith City Council and Griffith Community Centre Inc.

Hines construction are prefabricating the walls and columns that will be installed shortly after the slab is finished. It is anticipated that the project will be finalised by the end of July 2021, ready for occupation.

City Park Toilet Block

Modus are currently mid way through installing a custom toilet block in city park adjacent the BBQ area. The building is designed to mimic the existing red brick and galvanised structures in the park and will include an accessible toilet, 3 additional toilet cubicles and an outdoor shower.

Community Stage - Burley Griffin Community Garden

Work is currently underway in the Burley Griffin Community Gardens preparing the ground works for the new performance stage. The footings are currently being manufactured before being lifted into place.

Pump track

The Concept Design contract was awarded to Scape Design Studio of Sydney. The landscape and urban design firm were engaged from the Government Architects Shortlist of pre-qualified landscape consultants list. The firm will prepare an overall masterplan concept for the youth precinct which will then be used to tender for the pump track facility, which will be located in Olympic Street.

Olympic Street Car Park

Council resolved last week to award the contract for the design and construction of a 21 car park (including 2 accessible parking bays) to Hines Construction. This project

will begin in the coming weeks and will be finished just in time for the opening of the Community Centre and Pump Track.

Winter Delights in Kooyoo

This project is currently underway with a planning and delivery team being set up that includes tourism, theatre, governance and Urban design. Designs are already in progress for the parklets and mobile seating. This project is funded with thanks to a grant under the Streets as Shared Spaces program.

GSIL (FCR - Fixing Country Roads and R2R)

Stage 6b - Kidman Way Brown/Brogden intersection (Lavender Bend) has been making good progress, with the stabilising complete, the pavement subbase is under construction, the primer seal has been completed on Brown, Brogden and Bromley, with the asphalt to be undertaken. Ancillary works (guardrail, linemarking, guideposts) will be completing following the asphaltting. The power relocation and drainage is complete with the streetlighting and concreting medians to be finalised.

Henderson Oval

Designs on the new Henderson Oval playground have been finalised, thanks to consultation with residents of Yoogali. Work is expected to commence early 2021.

Affordable Housing

Council is working with Argle Housing to deliver affordable housing including 2 townhouses in Wakaden Street and a \$12M 20 home/25 lot subdivision in South Griffith.

General Manager Mr Brett Stonestreet said Council is committed to delivering the best possible outcomes for this community.

"Staff are continually reviewing and assessing the needs of this community, and are actively seeking funding in order to deliver the services needed," said Mr Stonestreet.

"Through these projects we are not only able to improve the lives of our community, but drive jobs growth across the region – every project needs hands on deck and whether it's contractors or Council staff, millions of dollars is being injected into the local economy."

The vandals who stole Christmas

Griffith Mayor, Councillor John Dal Broi has today expressed his disappointment as two of the City's Christmas attractions were switched off.

"Sometime after 11.30pm on Tuesday night, vandals severely damaged the two electricity boxes which operate the bauble and archway in Memorial Park, this was not only an extremely dangerous act, but has resulted in the closure of these two popular attractions," said Councillor Dal Broi.

"To say we are disappointed is a gross understatement – Council invested heavily in time and money to be able to provide Christmas cheer for this community, and it has taken less than a week for vandals to ruin it for everyone else. "We are fortunate that electricians could repair the electricity boxes, but we had to keep the arch and bauble switched off to ensure public safety in the interim," he added.

Council will be installing CCTV cameras in Memorial Park due to the ongoing issues with vandalism. "Following the Glow2680 launch last week, the archway was

damaged with lights broken. Later that evening, a group of teens took it upon themselves to attempt to push over the bauble – thankfully a staff member was present to stop this from occurring," said Councillor Dal Broi.

"We didn't believe it was necessary to install CCTV to protect the City's decorations, however following these incidences it is clear that we need to take steps to protect community property."

Repairs have now taken place and the decoration are now fully functioning and have reopened to the public.

If you have any information relating to the vandalism, please contact the Police on 6969 4299 or Council on 1300 176 077. Council has a policy in place (GC-CP-314) which is there to encourage the public to play a role in safeguarding the assets of the community. Under this policy, Council will pay a reward of up to \$2,000 to members of the public for information resulting in the conviction against persons damaging Council property – information received will be treated confidentially.

Not only did they manage to put a stop to others being able to enjoy the display until repairs can be made, they put their own lives at risk. I can only hope that in the cold light of day they take a good hard look at themselves and realise how selfish their actions were, but I doubt it.

These decorations are there for everybody to enjoy. A lot of hard work has gone into creating the beautiful display and to see vandals deliberately ruin it for the community is disheartening for us all. Not only does vandalism cost our community thousands of dollars each year, it means residents are inconvenienced. This doesn't only apply to the lights, it's also the case for our public toilets, which we are forced to close when damage is done.

On a brighter note, I'm pleased to say that at the last Ordinary Meeting, Council resolved to renew the General Manager's contract for three years. As far as I'm concerned this is an excellent result for Griffith. You only have to look around the City to see what

a fantastic job he has done and I have no doubt will continue to do. Throughout these difficult few months he has maintained an extremely professional manner and I thank him for that. I know that it hasn't always been easy especially when the keyboard warrior cowards on social media have been working overtime.
