- (1) Council modify Development Application No. 53/2015(1) for "Internal fit-out and use of a building as food and drink premises" issued on 28 April 2015 in the following manner:
- (a) Condition O(2) Hours of Operation Time Period be changed from "11:00 am to 12:00 am (midnight) Mondays to Sundays" to "8:00 am to 3:00 am Mondays to Sundays" for a trial period of twelve (12) months from the date the S.96(2) Notice of Determination for DA 53/2015(2) is issued, following which the hours of operation shall automatically

revert to "8.00 am to 12.00 am (midnight)" Mondays to Sundays.

(b) The following additional conditions of consent as recommended by NSW Police in their advice to Council dated 19 September 2016 be inserted into "Part O – On-going Requirements":

#### **CLOSED CIRCUIT TELEVISION**

The consent holder shall maintain a CCTV system at the above location that meets the following minimum requirements.

- (14) A camera must be located at the main entrance to the premises and positioned to record any person entering through this entrance. The CCTV recording of this camera must be sufficient to enable the identity of an individual to be established beyond a reasonable doubt when:
  - (a) The person represents not less than 100% of screen height, and
  - (b) There is an unobstructed view of the persons face.
- (15) In addition, CCTV cameras must be maintained throughout the premises with camera coverage to specifically record images of the following areas:
  - (a) All other public entrances and exits, whether or not in use at the time
  - (b) Staircases in multilevel premises
  - (c) All portions of the floor area accessible to the public
  - (d) Any external entrances to toilets
  - (e) The footpath area directly outside and adjacent to the premises
  - (f) A view of the street immediately in front of and adjacent to the premises.
- (16) The CCTV recordings of these cameras must be sufficient to enable the recognition of a person. A viewer must be able to say with a high degree of certainty whether or not an individual shown is the same as someone they have seen before when:
  - (a) The person represents not less than 50% of screen height, and
  - (b) There is an unobstructed view of the persons face
- (17) Camera views are not to be obstructed by temporary or permanent structures, signage or other impediments.
- (18) Camera recordings must meet the standards set in Conditions O(14) and O(16) at all times, either by way of camera technology and settings, and/or by maintenance of lighting, camera positioning, camera shades and other environment factors
- (19) Recording must:
  - (a) Be in digital format
  - (b) Record at a minimum of 12 frames per second, and
  - (c) Commence 1 hour prior to opening, and operate continuously until at least 1 hour after closure.

- (20) The correct time, date and camera identification must be automatically embedded on all recordings and be able to be read when the image is played back on a different system without interfering with the view of the target area.
- (21) Recordings should be retained for a period of 30 days before being reused or destroyed. The consent holder shall ensure that no person is able to delete or alter any recordings within the 30 day period.
- (22) When the premises are open and trading, at least one person shall be at the venue that is capable of accessing the CCTV system and is able to immediately review recordings and produce copies.
- (23) Immediate access to the CCTV system and the ability to review recordings on the system is to be granted to NSW Police officers or other regulatory officer upon request.
- (24) The CCTV system shall be able to reproduce a copy of the recordings on compact disk, DVD or USB memory stick and must be provided within one working day to the NSW Police officers or other regulatory officer upon request.
- (25) Prior to the commencement of trade each day, the CCTV system shall be checked to ensure the equipment is in full operating order. The time and date of each system check is to be recorded in the incident register.
- (26) If it is discovered that the equipment is not in full operating order, a record is to be made in the incident register. All reasonable steps must be undertaken to repair the system within 2 hours, details of which are to be recorded in the incident register.

#### **SECURITY GUARDS**

(27) The consent holder will ensure that on every Friday and Saturday night that the business trades past midnight - two licensed security guards are employed from 12:00 am until close of trade.

#### FREE FLOW OF PEDESTRIANS

- (28) Patrons are prohibited from congregating/remaining on the footpath outside the business after 12am midnight.
- (c) The following additional condition of consent as recommended by NSW Police in their advice to Council dated 19 September 2016 be inserted into "Part L Prior to Use or Occupation of the Development":

#### CUSTOMER SAFETY MANAGEMENT PLAN

(11) Prior to commencement of operation of the business between midnight and

3.00am a Customer Safety Management Plan shall be prepared by the consent holder in consultation with the Griffith City Council and Griffith Local Area Command. This plan must be submitted to Council for endorsement prior to the premises trading with the proposed extended hours. The Customer Safety Management Plan must include a range of measures which include but are not limited to, customer safety, utilisation of security guards, installation and maintenance of CCTV system and management of customers congregating/ remaining on the footpath outside the business when trading past 12 midnight.

(2) The modification application be referred to the Director Sustainable Development for the preparation and issue of the notice of determination.
