Two new Tesla Charging Stations for Griffith



Griffith City Council has resolved to accept a partnership proposal with Tesla Motors Australia, to provide two destination chargers for electric vehicles in Griffith.

The proposal was first presented to councils in 2018 as part of an Increasing Resilience to Climate Change strategy. Council has since been working on brokering a partnership with Tesla Motors.

Griffith Mayor, Councillor John Dal Broi welcomed the news, saying the installation of these charges will encourage Electric Vehicle (EV) Tourism in our City.

"Council staff have been working toward this partnership for some time, participating in an extensive campaign to promote EV tourism and transport across the region."

"Electric powered vehicles are the way of the future and Council is now able to offer two charging stations which will be installed at the Griffith Visitor Information Centre." Councillor Dal Broi said.

"Those with electric cars can now have the confidence to place Griffith on their itineraries, assisting with growing our tourism market and injecting more funds into the local economy - research shows that EV use in tourism positively impacts the environment and enhances sustainability for economic and social development."

The partnership involves Tesla Motors supplying at cost two destination chargers which will be available for public use, with Council funding the installation (\$10,000) and ensuing maintenance and use of the chargers for a minimum of three

Current projections indicate EVs will account for 55% of new car sales by 2040 (BNEF 2018). There is also set to be a major shift in EV ownership from next year when more affordable models become available in Australia.

"Part of Council's commitment to creating an environmentally sustainable city will be to seek 'charging' partners to join and extend the network, making it easier and more accessible for visitors and community members to charge their vehicles," added Councillor Dal Broi.

The charging stations are on route to Griffith and will be installed in the coming weeks. For more information on the charging stations, please contact Council on 1300 176 077.

Council rolls out new Planning **Portal**

Griffith residents and developers will be introduced to a new system that will help streamline the Property Development Application process.

The NSW Planning Portal, which goes live on Council's website from Monday 2 November 2020, provides an online environment where people can access planning services and information from anywhere at any time. This is a convenient alternative to paperbased transactions that can only take place during business hours.

Council's Customer Service Coordinator Trudy Kalteren said it was an exciting step forward in providing a more efficient system for Griffith residents.

"The aim is to have everything in one place where you will be able to view development applications online and easily track them," she said.

"Users can submit their development application through the portal and will receive updates on key phases along the process. It's simpler, faster and more transparent."


Griffith Mayor, Councillor John Dal Broi said, he was happy to see this new service introduced.

"This is good news for everyone. It will make life easier for developers and Council and offers a range of digital planning services, mapping tools and reporting tools to assist everyone involved in a proposed development," Councillor Dal Broi

"I know that the process hasn't always been as straightforward as we'd have liked, so this will certainly help simplify things."

The digital services, accessed via dashboards, improve application determination times, increase transparency of the planning greater system and ensure accountability of all stakeholders.

From 1 July 2021 it is mandatory that all development applications submitted through planning portal. Registered users gain access to a digital dashboard which helps them manage their applications through the system. Applicants can submit a DA online and Council will review the DA and as required, request and receive additional documents through the portal before making a determination. Are you a responsible pet owner? Update from the General



Dogs and cats are 'companion animals' under the Companion Animals Act 1998 and the Companion Animals Regulation 2008 which outlines responsibilities of owners.

Council's Environmental Health & Compiance Coordinator, Merryn Benham said Council Rangers have the power where necessary to enforce the law, ensuring that owners meet their responsibilities.

"Your dog or cat must be microchipped by 12 weeks of age, or before selling or changing ownership - this identifies your pet and helps locate your pet if it is lost or stolen,"said Ms Benham.

"Once your pet is microchipped, you must also Lifetime Register your pet with Council through the NSW Pet Registry - you can register, update and change details online to make the entire process easier for you."

The Registry (www.petregistry. nsw.gov.au) is available for cat and dog owners to:

- Create an owner profile
- Update their contact details
- Transfer ownership of pets
- Report their pet missing, and
- Pay most lifetime registration fees online.

"If you are unable to do this online, you can drop into Council and we will help you through the process," added Ms Benham.

When talking about responsible pet ownership, it is important to consider desexing. This is a surgical procedure performed by vets that prevents them from being able to reproduce.

"Did you know cats can start breeding as young as four months of age? The most common age to desex your pet is between 4 and 6 months, however they are never too old to be desexed," Ms Beham

behavioural benefits to desexing:

- Desexed animals are generally certain illnesses

"I would encourage you to contact your vet to organise desexing for your pet - Dogs desexed before 6 months of age, and cats desexed before 4 months of age receive a discount on Lifetime Registration," she said.

Chair of the Griffith Pound and Rehoming Centre Working Group, Councillor Doug Curran said it is vital for pet owners to abide by the rules and get pets desexed.

"Each week we are finding more and more pets abandoned in the pound, especially cats and kittens," said Councillor Curran.

"By desexing your pets, you are reducing the amount of unwanted cats and dogs which is the only way to end this cycle."

Another aspect to being responsible pet owner is ensuring your dog or cat does not harm or threaten any other person or animal. This means that you must be able to control your dog on your property and when you are in public with your dog you must always keep it on a leash. For cats you must ensure they do not recreate a nuisance to neighbours and keep it away from wildlife protection areas and food preparation or consumption areas. > Work on this building will commence late 2020 and is scheduled for completion early 2022. It will be located on the north-eastern side of the site adjacent to the southern boundary of St Vincent's Private Community

> The second stage of the Regional Sports Project is the West End Sports Stadium/Oval development. What an exciting project for Griffith and the Western Riverina. Tenders are likely to be called later this year,

we expect to start the construction during March/ April 2021.

The next stage of the Southern Industrial Link Road (Heavy Vehicle By-Pass) is progressing well at the intersection of Kidman Way/ Bromley Road/Brown Rd/Brogden Rd. (Often referred to as Lavender Bend). Works on this section are scheduled for completion at end of January 2021.

The Griffith Affordable Housing Project at Pioneer is progressing negotiations finalised between Griffith City Council and Land and Housing Corp. NSW for the transfer of ownership of land to Council. Council will undertake civil works such as roads, water, sewer, drainage, kerb and gutter etc and then transfer ownership of the land to our project partner Argyle Community Housing. Argyle will then construct 20 affordable dwellings and rent these to Griffith citizens who are employed but struggle to afford to enter the main stream housing rental market. There will also be 45 additional developed blocks which Argyle will make available for sale to Griffith citizens who meet "affordable housing" criteria. A community BBQ was held 21 October on site with residents of Pioneer to discuss the project and open dialogue regarding any concerns the community has. A large earthen mound is located in the centre of the site which will be removed prior to any development progressing. The project includes a community park and residents views have been welcomed as the design of the park layout progresses. Residents are particularly keen to have a basketball court included in the park or constructed on an alternative site. Employment and training opportunities for Pioneer residents, particularly Aboriginal citizens during construction are also being explored. Works on site are expected to commence first quarter of 2021.

Defibrillator now located at Griffith City Library



Griffith City Council wishes to advise that in the event of a cardiac arrest, an Automated External Defibrillator (AED) is now located at the Griffith City Library.

An Automated External Defibrillator (AED) is a small portable device which delivers an electrical shock to a person's heart to restore rhythm, allowing blood and oxygen to flow to the heart, brain and body. Having immediate access to a defibrillator can increase the likelihood of survival for people experiencing cardiac arrest.

Griffith Mayor, Councillor John Dal Broi said, giving immediate cardiopulmonary resuscitation (CPR) and using an AED early on can greatly increase the chance of survival.

"In the event of an emergency we encourage people to call triple zero (000) immediately, but knowing that this defibrillator is available for public use provides some peace of mind if it is required," Councillor Dal Broi said.

"You can use a defibrillator whenever CPR is needed and that is if a person is unresponsive and not breathing normally.

"The most important thing to remember is that time is crucial. If someone is unresponsive and not breathing, call an ambulance, start CPR and use a defibrillator as soon as possible."

Anyone can use an AED. The device will tell you what to do. Make sure the area around the person is clear. Don't touch the person while you are using the AED because this could interfere with how it reads the person's heart.

If necessary, the AED will tell you where to put electrodes (pads) on the person's body. The device may deliver more than one shock.

The AED may instruct you to continue CPR after the shock. Continue CPR until the ambulance arrives.

Located behind the customer service desk, the defibrillator can be used for both adults and children.

- Capacity building ensure NSW has the ability and commitment to manage invasive species

The Biosecurity Act 2015 – determines that all stakeholders including government agencies, industry and private landholders must demonstrate that they are meeting their General Biosecurity Duty and fulfilling their role in confronting the challenges and achieving the goals and actions outlined in the plan. Furthermore pest animal management is a shared responsibility between landholders, community, industry and Government and requires a coordinated approach across all scales and all land tenures including public and private lands.
