The Griffith RSL Sub Branch is encouraging the community to stop and remember those who have fought and died in defence of this great country by standing at the end of their driveways at 6am to 'Light up the Dawn'. Griffith's community radio station 2MIA will be holding their own service over the airwaves from

10.45am. Community members are urged to stay at home on Saturday, but you can still do your bit to help keep the ANZAC Spirit alive, it's more important than ever that we pull together in these uncertain times.

It is disappointing for our community that printing of The Area News has been suspended until the end of June due to the impacts of coronavirus and on behalf of Griffith we will be letting those in control of the paper know that we are unhappy about it.

informed as possible and have created the Council Catch Up Newsletter to help us reach as many people as possible.

This community newsletter will be produced each week and will include all the latest news, media releases, advertisements, positions vacant, Development Applications, messages from our Councillors and more.

We've made some changes to the website to make it easier to find this information. I urge you to subscribe and have this newsletter delivered to your inbox.

It is pleasing to hear that, at the time of going to print, no further cases of COVID-19 have been identified in Murrumbidgee Local

Health District (MLHD). I want to thank all of you for your continued support in doing the right thing and following the rules.

Let's keep up the good work, I know it isn't easy, but it's important to ensure the safety of our community.

Murrumbidgee Local Health District is urging people who have symptoms of COVID-19 to come forward to be screened for testing. Large-scale COVID-19 testing allows health services to quickly identify who has the disease and arrange for them to receive the care needed. Isolating known cases prevents them from coming into contact with others and slows the rate of transmission.

If you have a fever, sore throat, dry cough or

shortness of breath call the hotline on 1800 831 099 for a confidential over the phone assessment from 7am - 9pm.

Keep washing your hands regularly, stay home as much as possible, stop shaking hands, hugging, or kissing other people and clean and disinfect frequently touched surfaces regularly.

If we remember these important tips we can reduce the potential for virus transmission and that will get us closer to being able to rebuild our lives and return to some form of normality.

Please, stay safe and stick together Griffith - from 1.5m apart.

## Take our MLAK survey

Griffith City Council is reviewing the Master Locksmith Access Key (MLAK) system and is urging those living with a disability or their carers to help by providing feedback.

The MLAK system is used to access the disabled toilets in the Griffith Local Government Area (LGA) at any time of the day or night. Council provides a free MLAK key to any eligible person making an application.

# Citizenship Ceremonies affected by Coronavirus

Griffith City Council wishes to advise that due to the Australian Government's precautionary measures in response to the COVID-19 pandemic citizenship ceremonies have been placed on hold.

The Department of Home Affairs is now working to introduce online citizenship ceremonies via secure video link, to enable people to continue to become Australian citizens. These ceremonies will be one-on-one with the presiding officer. Ceremonies performed via video link will continue to include integrity measures, like identity

requirements.

The Department will be in contact with conferees with full details in due course. There is no need to contact the Department or Council about your ceremony. The Department will recommence in-person interviews and citizenship tests when it is safe to do so.

# Council adopts first Reconciliation Action Plan (RAC)

Griffith City Council has reinforced its long-standing commitment to reconciliation with the development of its first Reconciliation Action Plan (RAP).

The Innovate Reconciliation Action Plan 2019-2021 was adopted at the Ordinary Council Meeting held on 24 March 2020 following months of development in collaboration with Reconciliation Australia and extensive input from the local Wiradjuri community.

Griffith Mayor, Councillor John Dal Broi said the Innovate Reconciliation Action Plan provides a framework to demonstrate Council's commitment to Aboriginal and Torres Strait Islander peoples.

"It's unfortunate that due to the Coronavirus and the disruptions it has caused we haven't been able to officially launch this important document in the way we would have liked," Mayor Dal Broi said. "Council's RAP builds on and strengthens the existing relationship with Griffith's Aboriginal and Torres Strait Islander population and showcases Council's dedication and commitment to reconciliation. "This is a strategic document involving all departments within Council. Implementing it across such a large and diverse organisation presents challenges but Council is ready and committed to putting the initiatives into practice."

The RAP includes four standard elements relating to relationships,

respect, opportunities and governance with a commitment to reconciliation by fostering an inclusive community that supports the interests of Aboriginal and Torres Strait Islander peoples.


The Griffith Aboriginal Community Working Party (CWP) took a strong interest in creating the document. The RAP was a standard agenda item over 18 months working closely with Council's Community Development Officer - Aboriginal Liaison to develop mutually acceptable outcomes.

A number of discussions regarding the RAP were held with the Griffith Aboriginal Medical Service, the Local Aboriginal Lands Council, Dyrri-Bang-Gu and the NSW Department of Aboriginal Affairs.

Reconciliation Australia supported the development of this document by giving the RAP conditional endorsement in late 2019 to ensure all sections of the document aligned with their guidelines. They gave their full endorsement of Council's Innovate RAP on 21 February 2020.

The RAP includes local history, an overview of significant activities and events along with identified deliverables and timeframes to be undertaken across all Council departments over the coming two year period.

## Ordinary Council meetings of Council set to be live streamed via facebook

COVID-19 has even changed the way Councillors will meet. The Minister has allowed Council Meetings to be conducted offsite from the Council Chambers with Councillors accessing the Meeting from their homes.

The next Ordinary Meeting of Council to be held on Tuesday 28 April 2020 will be held remotely using Zoom Audio Video conferencing technology.

The Council Meeting will be live streamed through Council's Facebook page. The live stream will be stopped during Closed Council (Confidential section) and recommenced after Open Council resumes.

The audio recording of the Council Meeting will be placed on Council's website (as per current practice) the following day and the visual recording will be available to view on Facebook.

Due to the COVID 19 measures put in place, members of the public can address Council either by attending the Council Meeting at the Council Chambers and presenting to the Mayor (in person) and to Councillors (online)

or submit their comments in writing by 12 noon on the day of the Council Meeting. Comments or submissions received will be read out at the meeting during deliberation of the item following approval by the Mayor. In accordance with Council's Code of Meeting Practice, public addresses must be in respect to matters on the meeting agenda. The Covid-19 Public Addresses to Council Declaration form must be submitted by 12 noon on the day of the Council Meeting. Comments or submissions received will be read out at the meeting during deliberation of the item following approval by the Mayor. 
